Sub: Local officiating arrangement in the cadre of AOs-reg.

The Assistant Accounts officer/Junior Accounts Officers mentioned in the enclosed Annexure are locally promoted and posted to officiate as Accounts Officers as noted against each **with immediate effect.**

The above local officiating arrangements are made on purely temporary basis and this will not confer any right on the officer to continue in the same post/grade/station. The above arrangements are purely temporary till the regular incumbent posted/joins or till further orders from this office whichever is earlier, but not likely to exceed 89 days.

The above officers will stand automatically reverted to their original cadre on 89th day or on joining of the regular incumbents whichever is earlier if no further orders are issued by this office in the meanwhile.

The arrangements made under this order will neither bestow on the officer any right to claim for their regular appointment in the grade of AO nor the service rendered by them will count for the purpose of seniority in the grade or for promotion to the next higher grade.

The above officiating arrangements are subject to the conditions that there is no vigilance/disciplinary case is pending against the officer or some punishment like stoppage of increment is current.

In the case of officers posted to officiate out of the SSA in which they are working as JAOs, may first be transferred to the SSA in the substantive grade and be posted directly to officiate as Accounts Officers.

The pay of the officers will be fixed as per instructions issued vide OM No.1-50//2008-PAT(BSNL)/ dated 05-03-2009 read with Ir. No.400/61/2004-PERS-I dated 18.01.2007.

If the officers does not assume charge within fifteen days, he / she will be deemed to have declined the officiating promotion and debarred for a period of one year.
