The above arrangement is purely temporary till regular incumbent posted/join or till further orders from this office whichever is earlier, but not likely to exceed beyond 89 days.

The above officers will stand automatically reverted to their original cadre on the 89<sup>th</sup> day or on joining of the regular incumbent whichever is earlier if no further order is issued by this office in the meanwhile.

The arrangement made under this order will neither bestow on the officer any right to claim for their regular appointment in the grade of CAO nor will the service rendered by them count for the purpose of seniority in the grade or for promotion to the next higher grade.

The above officiating arrangement is subject to the conditions that there is no vigilance/disciplinary case is pending against the officer or some punishment like stoppage of increment is current.

As all the officers ordered above to officiate as CAOs are already drawing the STS Pay scale under time bound upgradation, they are not entitled for fixation benefits.
