On successful completion of field training, as ordered vide this office letter no. RET/251-12/2016/Trg/83 dated 09.11.2016 posting of TTAs to the grade of JTO(T) under 50% (INTERNAL) quota for the Vacancy Year 2013-14 held on 22.05.2016 after completion of field training are listed in the enclosed annexure. The SSAs/Units to which they are posted is noted in the annexure against their names.

The officials have undergone 10 weeks Phase - I training in Batch No.B-12(MM) at RTTC, Maraimalai Nagar Chennai from 17.10.2016 to 23.12.2016 and are undergoing 4 weeks field training with effect from 26.12.2016 to 21.01.2017. **On completion of 4 weeks JTO field training by the qualified TTAs only the JTO posting order may be issued by the concerned SSA/UNIT.**

The officials are eligible for Pay and other admissible allowances in the JTO Pay scale of Rs. 16400 – 40500 as prescribed by BSNL, New Delhi letter No. 1-50/2008 PAT (BSNL), dated 05/03/2009, from the date on which they report for duty. Since they are posted against the regular JTO vacancies in the SSA/Unit, they are to be taken in strength of the respective SSAs/Units as per the instructions contained in BSNL Corporate office, New Delhi letter no. 4-1/04-Trg. Dated 23/06/2006.

The Heads of SSAs/Units may communicate the station of posting to the respective CGMs/GMs concerned, under intimation to this office. The station of posting as decided by the SSA/Unit Heads will be their new Head Quarters.


These posting orders are provisional and the year of Recruitment will be finalized subject to the outcome of SLP(C) No. 27070 of 2015, OA 1578 of 2015, OA 1629 of 2015 and SLP (C) No. 28317 of 2015 and final judicial orders passed in similar pending cases.

These JTOs will undergo 6 weeks Phase-II training compulsorily within two years in order to be eligible for second increment.
