Sub: Transfer and postings in the grade of Accounts Officers in Tamilnadu Circle – reg

Ref: CGM, TN Circle Officer Letter No : TSA(F)/ 12-14/2016-17/48 dated at CH the 16-12-2017.

This is with reference to the T N Circle office letter cited above transferring 9 Accounts Officers only from 5 SSAs including Circle Office. The purpose of the transfer in the middle of the academic year is not known since it is stated to be in the interest of service.

In case the transfer is ordered on the basis of long stay in a particular station, the same yard stick is not uniformly applied to finance personnel working in all the SSAs and only personnel from five SSAs have been issued with the orders of transfer.

In case the transfer is ordered in the context of surplus, the same may not be correct as volunteers among JAOs/ AOs were called to work in the Taxation wing of Tamilnadu Circle Office vide letter No: TSA(F)/MISC/2014/5 dated at Chennai the 02.05.2017. After issuance of this letter, only one AO was transferred from Thanjavur to circle office and the question of surplus in circle office does not arise. Similarly in Madurai SSA at present one AO post is vacant due to VR and four posts of AO are likely to be vacant by way of superannuation retirements by March 2018 (Dec_17 – 1, Feb_18-1, Mar_18 -2).

In Tirunelveli SSA also requirement is fulfilled by posting of 2 AOs from other circles viz STR and Gujarat, very recently (Smt P. V. Kamala and V. S. Muniyandi). Thus the question of surplus in these two SSAs also does not arise.

Now APAR particulars have been called for the promotion to the cadre of AOs from JAOS by Corporate Office and there is possibility of issuance of promotion order shortly and transfer of AOs at the time of promotion may be considered among promoted officials. All the officials under order of transfer will be under stress due to transfer in the middle of academic year.

In view of the above, it is requested to re-examine this transfer order by assessing meticulously the requirement in cadre of finance personnel of all SSAs and without restricting the transfers to only particular SSAs.
